DISCIPLINARY RULES

1. A student is expected to have high standard of discipline and conduct in a proper manner befitting the reputation of Tula's Institute.
2. He/She shall show due courtesy and consideration to the employees of the Institute, good behavior to his/her fellow students and respect to the teachers of the institute and courtesy to the visitors.
3. For the maintenance of discipline among the students of the Institute Standing Discipline Committee for students of the Institute will examine the cases of students involved in breach of rules of conduct and recommend a suitable disciplinary action.
4. In case of damage to any furniture, apparatus or any other property of the institute, the damages will be charged from the student or student known to be directly concerned. However, if the students who cause the damage are unknown, the cost of damage shall be charged equally from all the students of the Institute/Class.
5. No society or association or club shall be formed without the prior permission of the Head of Institute.
6. Student should come to college in college uniform.
7. Smoking in campus is strictly prohibited.
8. Cell phone should be switched off when the student enters the college premises. They can use the same during Lunch Break, but outside the classrooms or Labs.
9. Students are not allowed to organize any get-together, function without the permission of Chairman/Director.
10. Students are required to display the identity card issued by the institute during their stay in the premises. The security at the main gate shall deny entry inside the premises in the event of non-possession of I-Card.
11. Students are required to reach college at 9.30 am on all working days.
12. College timing is 9.30am to 4.30pm. No student is allowed to leave the college premises without the permission of concerned authority.

NOTICE

General Responsibility:

All the faculty members of the Institute shall have the collective responsibility in sensitizing the senior students and counseling the fresher's about their rights as bonafide students of the Institute and preventing acts of ragging. They shall promptly and without fail report any act of ragging to the Director of the Institute, Anti Ragging Committee, verbally and in writing. If it is found that any person having knowledge of ragging has concealed any such information, action may be initiated against the person(s) concerned as per Institute regulations and the orders of the Hon'ble Supreme Court/AICTE.

Functions and Duties of Anti-ragging Squad:

1. To be vigilant at all hours including at odd hours all-round the campus and other places vulnerable to incidents of, and having the potential of, ragging and shall be empowered to inspect such places.
2. Conduct anonymous random surveys among fresher to check whether the campus is indeed free from ragging.
3. To conduct on-the-spot enquiry into any incident of ragging referred to it by the head of the institution or any member of the faculty or any student or any parent or guardian or any employee of a service provider or by any other person, as the case may be; and the enquiry report along with recommendations shall be submitted to the anti-ragging committee for action under clause (a) of regulation 9.1 of U.G.C.
4. To ensure that posters/tabs are displayed prominently at main and departmental notice boards and other places such as canteen, library, and sports lounge, gymnasium, Bus stops and other prominent places.
5. To monitor the welfare of fresh students outside the campus.
6. To assist the Anti-Ragging Committee to faithfully implement the order of the Supreme Court/ AICTE.
7. To educate the Senior Students to help their junior students and not to indulge in acts of ragging.
8. To monitor and take all possible preventive measures to stop ragging of the students in the respective areas of the Tula's Institute.
9. To counsel the students involved in ragging
